



This is a legal document, which carries the full weight of legal authority of the State of Colorado legal system made between you and Regional Transportation District, hereafter known as RTD, and Central Parking System, hereafter known as CPS.

By clicking the submit button on this form, you agree:

- 1. That all information enclosed on this form are true and accurate
- 2. That failure to register your vehicle at an address within the RTD district, as submitted on this form, will result in legal action for fines and parking, and collection fees that are not paid within 30 days of expiration of this exemption
- 3. That you will abide by the rules and regulations applicable to in-district parkers as set forth on the RTD web site at http://www.rtd-denver.com/HowToPark.shtml
- 4. You are <u>not</u> automatically exempt until you have received a confirmation e-mail, with the start date, and an expiry date, from #######
- 5. As an in-district parker, you may park in any space other than a designated RESERVED space (between 5am-10am, Mon-Fri)
- 6. That while parking on RTD property, you will use the RTD transit system only, and park for no other reason
- 7. Charges, if parking over 24 hours, are for parking space only, neither RTD or CPS assume any responsibility whatever, for the loss or damage of the vehicle, or its contents, however caused.
- 8. That you have read, and understand the terms and conditions of this agreement

You must continue to pay "out" of district rates until you get confirmation you have been approved. You will also be responsible for <u>any</u> violations you received before the exemption is in effect.

This Agreement constitutes the entire agreement between you and RTD/CPS and governs your use of the RTD Service, superseding any prior agreements between you and RTD. You also may be subject to additional terms and conditions that may apply when you use affiliate services. If any part of this Agreement is held invalid or unenforceable, that portion shall be construed in a manner consistent with applicable law to reflect, as nearly as possible, the original intentions of the parties, and the remaining portions shall remain in full force and effect. RTD's failure to enforce any right or provisions in this Agreement will not constitute a waiver of such or any other provision. RTD/CPS will not be responsible for failures to fulfill any obligations due to causes beyond its control. You agree to comply with all local, state, federal, and national laws, statutes, ordinances, and regulations that apply to your use of the RTD Service. Your use of the RTD Service may also be subject to other laws. You expressly agree that exclusive jurisdiction for any claim or dispute with RTD/CPS or relating in any way to your use of the RTD Service resides in the courts in the State of Colorado. RTD/CPS reserves the right to take steps RTD/CPS believes are reasonably necessary or appropriate to enforce and/or verify compliance with any part of this Agreement. You agree that RTD/CPS has the right, without liability to you, to disclose any Registration Data and/or Account information to law enforcement authorities, government officials, and/or a third party, as RTD/CPS believes is reasonably necessary or appropriate to enforce and/or verify compliance with any part of this Agreement (including but not limited to RTD/CPS right to cooperate with any legal process relating to your use of the RTD Services.
