**Writers:** Provide up to 5 examples or extracts of written work of up to 500 words each in a PDF file. If the submitted piece is an extract of a longer work, you may provide at the end of the extract a link to a PDF of the full work.

**Multi-media/digital artists:** Submit a short showreel of up to 15 minutes duration or up to 5 individual examples of no more than 5 minutes duration. If the files are larger than 25 MB, please provide a link to download the files. Link(s) must remain active but can be password protected. Please provide the password and link(s) in a PDF or Word document.

**Actors/Performers:** Submit a short showreel of up to 15 minutes duration or up to 5 individual examples of no more than 5 minutes duration. If the files are larger than 25 MB please provide a link to download the files. Link(s) must remain active but can be password protected. Please provide the password and link(s) in a PDF or Word document.

**Musicians/Sound artists:** Provide up to 5 examples of your work as individual mp3 or other relevant audio files.

**TV/Film:** Please note, we are seeking creative practitioners rather than technical practitioners for the Artist Pool. Please provide relevant examples - either a short showreel up to 15 minutes duration or up to 5 individual examples of no more than 5 minutes duration OR other visual or written examples (see formats listed above). \*
