OFFICIAL RULES

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

The “TR Dream Honeymoon” Sweepstakes (the “Sweepstakes”) is intended for legal residents of the 50 United States of America (USA), the District of Columbia, and Canada (excluding the Quebec province) and shall only be construed and evaluated according to U.S. and Canadian law.
