

OFFICIAL RULES COMPTIA SWEEPSTAKES

1. **ENTRY RULES.** NO PURCHASE NECESSARY TO ENTER. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. At the time of entry, you must meet the requirements set forth in the ELIGIBILITY section. Prize drawings will be conducted under the supervision of CompTIA whose decisions are final and binding. The winner will be notified as set forth below in the NOTIFICATION section.
