



Saginaw County Opioid Settlement Fund Request for Funding Application – Fiscal Year 2026

Organizations or groups (including for-profit, non-profit, 501c3 organizations, schools, churches and other non-profits) addressing opioid prevention, harm reduction, treatment, and recovery are eligible for funding to support the development, implementation, enhancement, or expansion of programs. This includes programs addressing substance use disorders, polysubstance use and co-occurring mental health and substance use disorders. **Request for Opioid Settlement Funds will be accepted on a rolling basis until all funds have been allocated. Organizations that were not initially funded during a review period may apply again during future funding quarters.** Applications must be completed online using the [Saginaw County Opioid Settlement Fund Request Application](#).

The goal of this opportunity is to serve Saginaw County through development, implementation, enhancement, or expansion of evidence-based strategies or promising practices to prevent and address the adverse impacts of the drug overdose epidemic.

Award of Funds: Organizations will be allowed to submit for the amount of funding anticipated to perform the work of the program/project.

- Organizations shall be prepared to present their funding request to the Overdose Prevention and Response Funding Advisory Team.
- Given the number of requests anticipated to be received, organizations **may not** be granted the full amount of funding requested.
- If the indirect costs exceed more than 25% of your budget, you are required to provide detailed justification.
- Organizations awarded funding are required to:
 - a. Ensure utilization of funds supplements, rather than supplants, existing funding.
 - b. Ensure all funds are used in alignment with [Exhibit E](#) and the definition of opioid remediation.
 - c. Provide quarterly reports to the Opioid Funding Advisory Committee and a final report to the Board of Commissioners.
 - Reports must include data on program outputs, outcomes, impact, and effectiveness,
 - Organizations should be prepared to provide an oral presentation to the Board of Commissioners.

Requirements:

- Proposal Priorities
 - a) Utilize funds to serve those in Saginaw County.
 - b) Focus on individuals and communities most profoundly impacted by opioid use disorder (OUD) and co-occurring substance use disorder/mental health conditions (SUD/MH)
 - c) Organizations may be requested to provide a copy of the following:
 - Articles of Incorporation
 - Bylaws
 - Budget Balance Sheet or Most recent Audit of Financials
 - Proof of Insurance
 - Licenses and Certifications

Allowable Uses of Funds & Funding Restrictions:

Specific to the J&J, Distributor, CVS, Teva, Allergan and Walmart settlements, funds must be spent on opioid remediation. Opioid Remediation is defined as,¹ Care, treatment, and other programs and expenditures (including reimbursement for past such programs or expenditures except where this

Agreement restricts the use of funds solely to future Opioid Remediation designed to (1) address the misuse and abuse of opioid products, (2) treat or mitigate opioid use or related disorders, or (3) mitigate other alleged effects of, including on those injured as a result of, the opioid epidemic.

Activities must meet the definition of opioid remediation, be evidence-based strategies or promising practices and align with allowable uses outlined by [Exhibit E](#). These strategies include:

Core Strategies ([See Exhibit E – Schedule A: Core Strategies for More Information and Examples](#)):

1. Naloxone or other FDA-approved drug to reverse opioid overdoses.
2. Medication-assisted treatment (“mat”) distribution and other opioid-related treatment.
3. Pregnant & postpartum women
4. Expanding treatment for neonatal abstinence syndrome (“NAS”)
5. Expansion of warm hand-off programs and recovery services.
6. Treatment for incarcerated population
7. Prevention programs
8. Expanding syringe service programs
9. Evidence-based data collection and research analyzing the effectiveness of the abatement strategies within the state.

Approved Uses for Prevention, Treatment, Recovery, and Harm Reduction ([See Exhibit E – Schedule B: Approved Uses For More Information and Examples](#)):

1. Prevention/Harm Reduction
 - Prevent over-prescribing and ensure appropriate prescribing and dispensing of opioids.
 - Prevent misuse of opioids.
 - Prevent overdose deaths and other harms (harm reduction).
2. Treatment/Recovery
 - Treat Opioid Use Disorder (OUD)
 - Support people in treatment and recovery.
 - Connect people who need help to the help they need (connections to care)

- Address the needs of criminal justice-involved persons.

- Address the needs of pregnant or parenting women and their families, including babies with NAS.

3. Other Strategies

- Supporting first responders
 - Training on how to respond to overdoses.
 - Support for secondary trauma for responding to overdoses.
- Leadership, planning and coordination.
- Training
- Research

Selection and Award Process

1. All proposals submitted must include the completed [online request for proposals document](#), completed detailed work plan, completed budget and budget justification, and any other requested documents.
2. Organizations shall be prepared to present their funding request to the Overdose Prevention and Response Funding subcommittee if requested.
3. Proposals will be reviewed and scored by the Overdose Prevention and Response Funding Advisory Team.
4. Recommendations on award of funding from the Funding Advisory Team will be submitted to the Saginaw County Board of Commissioners for review and approval.

Proposals may be submitted on an ongoing basis with proposals being reviewed quarterly by the Overdose Prevention and Response Funding Advisory Team. Please see above for application submission and review dates. Following the notice of award, organizations will be contacted to initiate the contract process with the County of Saginaw.

Funding Request Review and Scoring:

All requests for funding will be evaluated and scored based on the following:

1. Did the organization provide a complete application including detailed intervention description, work plans, budget, and timeframes?
 - a. The problem or issue the program/project will address is clearly stated.
 - b. Did the organization clearly describe what they need to do to accomplish their project?
 - c. Did the organization clearly describe how the project will address, prevent, or reduce overdoses in Saginaw County.
 - i. Does the intervention save lives?
 - ii. Is the intervention evidenced-based or a promising practice?
 - iii. Does the intervention invest in youth?
 - iv. Does the intervention have a focus on racial equity?
2. The funding request clearly describes the community need(s) addressed by the project.
 - a. Does the organization provide data showing the need for this program/ project?
 - b. Is the target population identified? Demographics, including socioeconomic status, gender, age, ethnicity, languages, disabilities etc., of the community being served are identified.
 - c. How the community/participants will benefit from the program/project is clearly stated.
3. The funding request clearly describes a plan for how the program/project will be sustained beyond the grant period both financially and operationally.
4. The funding request clearly describes the plan to measure program/project performance.
 - a. Data that will be collected and how it will be collected is clearly stated.
 - b. Data being used for evaluation of the program/project will clearly show the effectiveness of the program/project.

 - Provide comprehensive wrap-around services to individuals with OUD, including housing, transportation, job placement/training, and childcare: **Goal Statement**

- d) Expanding treatment for neonatal abstinence syndrome (“NAS”)
 - Expand comprehensive evidence-based and recovery support for NAS babies: **Goal Statement**
 - Expand services for better continuum of care with infant need dyad: **Goal Statement**
 - Expand long-term treatment and services for medical monitoring of NAS babies and their families: **Goal Statement**

- e) Expansion of warm hand-off programs and recovery services.
 - Expand services such as navigators and on-call teams to begin MAT in hospital emergency departments: **Goal Statement**

 - Broaden scope of recovery services to include co-occurring SUD or mental health conditions: **Goal Statement**
 - Provide comprehensive wrap-around services to individuals in recovery, including housing, transportation, job placement/training, and childcare: **Goal Statement**
 - Hire additional social workers or other behavioral health workers to facilitate expansions above: **Goal Statement**

- f) Treatment for incarcerated population
 - Provide evidence-based treatment and recovery support, including MAT for persons with OUD and co-occurring SUD/MH disorders within and transitioning out of the criminal justice system: **Goal Statement**
 - Increase funding for jails to provide treatment to inmates with OUD: **Goal Statement**

- g) Prevention programs
 - Funding for media campaigns to prevent opioid use (similar to the FDA's "Real Cost" campaign to prevent youth from misusing tobacco): **Goal Statement**
 - Funding for evidence-based prevention programs in schools: **Goal Statement**
 - Funding for medical provider education and outreach regarding best prescribing practices for opioids consistent with the 2016 CDC guidelines, including providers at hospitals (academic detailing): **Goal Statement**
 - Funding for community drug disposal programs: **Goal Statement**
 - Funding and training for first responders to participate in pre-arrest diversion programs, post-overdose response teams, or similar strategies that connect at-risk individuals to behavioral health services and supports: **Goal Statement**
